

Coca-Cola® Circle K Gulf Coast Home Court Sweepstakes

Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN. TEXT MESSAGING IS NOT REQUIRED FOR ENTRY. EACH TEXT MESSAGE SENT OR RECEIVED MAY INCUR A CHARGE AS PROVIDED IN YOUR RATE PLAN. MESSAGE AND DATA RATES MAY APPLY. IF YOU ENTER VIA TEXT MESSAGING, YOU WILL RECEIVE UP TO 3 TEXT MESSAGES IN RESPONSE TO YOUR ENTRY. TEXT MESSAGING MAY NOT BE AVAILABLE THROUGH ALL WIRELESS CARRIERS.

- 1. Eligibility:** The Coca-Cola® Circle K Gulf Coast Home Court Sweepstakes (the "Sweepstakes") is open only to legal residents of Alabama, Arizona, Florida, Louisiana, Mississippi and Tennessee who are 18 years of age or older at the time of entry. Employees and non-employee workers of The Coca-Cola Company, Coca-Cola bottlers, Circle K Stores, Inc., iLoop Mobile, the National Collegiate Athletic Association ("NCAA"), Turner Broadcasting System, Inc., CBS Broadcasting Inc., ePrize, LLC, and their respective parent companies, subsidiaries, affiliates, and agents and those prize providers and agencies that are involved in the development or execution of this Sweepstakes or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. - 5. How to Enter:** There are 2 ways to enter:

- b) **Online Alternate Method of Entry:** During the Promotion Period, visit <http://www.cokeplaytowin.com/homecourt> and follow the links and instructions to complete and submit the registration form, including providing a valid home address. P.O. Boxes are not permitted. You automatically will receive 1 entry into the Sweepstakes.
